**CALL TO ORDER**

**APPROVAL OF MINUTES**

- **Subscription Site Update:**

- **Portal Conversion Schedule:**  
Mr. Gregg reported that the Portal Conversion is on schedule.
- **NINGA update**  
Ms. Stromberg reported that NINGA is requesting a list of streets that run through different counties with different names, NINGA requires that those streets have the same name county wide which would affect 3 counties. The NINGA team pushed back and did not want the street names to change and NINGA has agreed and requested a list of the roads that are named differently so they can provide to dispatch.

- **Tiling Scheme/Zoom Levels:**  
Mr. Gregg stated that WinGIS has the aerials and Ms. Stromberg will be working on the tiling and there has been questions regarding the zoom levels ESRI and WinGIS uses. Mr. Gregg stated that WinGIS plans on using the 12 ESRI levels that most closely represents what WinGIS currently has.

- **Spatial Index rebuild:**  
Ms. Stromberg will be rebuilding the spatial index over the weekend.

Mr. Stromberg asked about 10.6 and using it when it comes available? Mr. Gregg stated that WinGIS is still getting everything upgraded to 10.5 and has not looked at the next upgrade (10.6).

### **WinGIS Cooperative Agreement**

Mr. Thompson asked what the status is on the WinGIS Cooperative Agreement. Mr. Gregg stated that the WinGIS Cooperative Agreement was approved on August 29, 2018 and members are taking to their own individual boards for approval. Mr. Gregg indicated that he's hoping that by the next WinGIS Policy Committee meeting that each individual member's boards have provided their approval and the WinGIS members can sign the final Cooperative Agreement at the October 25, 2018 WinGIS Policy Committee meeting.
