a) Technical Committee Updates

representative from the Winnebago County Forest Preserve, Mike Brien, attended the most recent WinGIS Technical Committee meeting inquiring about membership.

a) Board Chair positions policy to align with R1PC

In keeping in alignment with the other R1boards. WinGIS will remove the term limit placed on board positions. Votes for Board Chair and Vice Chair will still take place annually.
