CALL TO ORDER

The meeting was called to order at 9:04 AM

OLD BUSINESS

a) Public/Subscription Site Update

Mr. Gregg informs the committee public and Subscription sites are ready to go live. Because, however, the Portal upgrade is scheduled to take place, WinGIS will postpone releasing the public and Subscription sites until the Portal upgrade is complete as well as any troubleshooting afterwards.

b) Enterprise/Software Upgrades

Mr. Gregg informs the committee that the Enterprise upgrade has begun. Due to some technical issues Cloudpoint encountered the upgrade has taken more than a day, like originally planned. Cloudpoint has been in touch with Esri in an effort to troubleshoot the issue. In the meantime, maps are still in place for users while Portal is unavailable.

NEW BUSINESS

a) New WAN

Mr. Gregg informs the committee that at some point in the future (within the next few months) the WAN will be relocated from WinGIS server ws01 to server ws05, resulting in an address change from imsserver.wingis.local to agis.wingis.org. This will allow WinGIS to no longer have to lease ws01 since they had to add ws07 in the course of the Portal upgrade. This will result in WinGIS leasing the same number of servers in the coming fiscal year, rather than one additional. Mr. Gregg will work with IT to

create a DNS entry to forward users going to imserver.wingis.local to agis.wingis.org alleviating some of the issues with the transition.

Technical committee members inform WinGIS which maps are still in use and which are no longer necessary.

Leeana Alcantar is now a full-time employee at the Park District and is now the official Technical Committee member for them.

Jon Oelschlager (CoR) informs the committee about issues to beware of is using the Attribute Assistant add-on when using ArcMap on Windows 11.
