OLD BUSINESS

a) Technical Committee Updates

Mr. Gregg informs the committee that the new public site is nearly ready for roll out. After that, internal site upgrades will be taking place. Lastly, Mr. Gregg informs the committee that the aerial photography flight will be occurring within the next several weeks.

NEW BUSINESS

a) Staffing Update

Mr. Gregg reports that despite a promising interview and even an offer that was extended, a potential GIS Specialist has turned down the position. The search for a candidate for that position will continue. Tara DeRosa suggests reaching out to NIU or UW Whitewater to get the position on their job board. Mr. Dunn also informs the group that the R1 has a contract with a recruiter who has the position as well.

b) Upgrades and Expenditures

Mr. Gregg reports WinGIS will be hiring consultant Cloudpoint Geospatial (which they have in the past) to assist in a software upgrade, making the WinGIS Portal only available to those on the internal network. This upgrade will result in WinGIS also having to lease one additional server from WinCo IT as well as an additional server license from Esri. Mr. Gregg will work with agencies to ensure contingencies are in place for the users while Portal is unavailable during the upgrade.

Mr. Dunn updates the committee that the beginning stages or our iFiber installation have begun.
