CALL TO ORDER

The meeting was called to order at 9:01 AM

APPROVAL OF MINUTES

Motion to approve the October 19, 2023 minutes made by **Winnebago County**: Seconded by **Four Rivers Sanitation Authority**. Motion passes by a **6:0:2** vote.

OLD BUSINESS

a) 911 Updates

Mr. Gregg informs the committee that Mrs. Stromberg is not present at the meeting because of 911/server maintenance taking place.

b) Public/Subscription Site Update

Mr. Gregg informs the committee that the new tentative go live date for the new Public/Sub site will be February 2024. A preview will be made available for both internal users – though they use the internal site – as well as the general public. Steve Thompson requests that LP/MP Enterprise Zones be listed under Machesney Park as well as Loves Park. Mr. Gregg then suggests that perhaps that all Economic Development layers be placed in a Ec. Dev. heading, rather than under each individual city/municipality.

NEW BUSINESS

a) Map Gallery Portal Web Application Proxy Error

Mr. Gregg recently made an update in IIS on the web server to load balance site traffic amongst web sites/maps in an effort to eliminate the proxy error that occasionally appears when accessing the WinCo Layers Web App made from the Portal template.

b) SQL Server Upgrade

WinCo IT upgraded WinGIS' version of SQL Server in an effort to prepare for agenda item C, our Enterprise upgrade.

c) Enterprise Upgrade

With the assistance of Cloudpoint Geospatial, WinGIS will be upgrading to Enterprise 10.9.1 from 10.7.1. Pending a little investigation, WinGIS' plan is to, upon upgrading, Portal would be entirely behind the firewall. This would make Portal and all of it's maps and applications available to everyone on the WAN without requiring login credentials. This would mean purchasing another license for a second instance of ArcServer (just ArcServer, not all of Enterprise) for public facing maps. The date scheduled for the upgrades is February 19th.

Just Kink mentions that All Layers web service is currently shared with "Everyone" and inquired if that was by design or an error. Steven Gregg indicates he will investigate.
